

AMENDMENT TO THE RISON FAMILY REVOCABLE TRUST

We, WILLIAM EDWARD RISON and SHERRY LYNETTE RISON, Grantors, hereby make and declare the following amendments to THE RISON FAMILY REVOCABLE TRUST u/t/a dated October 29, 2014:

1. Section 4 is rescinded in its entirety and left blank.
2. Section 5 is rescinded in its entirety and left blank.
3. Section 6 is rescinded in its entirety and replaced with the following:

SECTION 6. DISTRIBUTION.

- I. If WILLIAM EDWARD RISON was the surviving Grantor, then upon his death distribution of the trust estate shall be as follows:
 - A. To WALTER RISON all of the astronomy, photography, and computer equipment, including the right to move the observatory if he so chooses, provided that he survives WILLIAM EDWARD RISON by 30 days or more;
 - B. To SUSAN PATTON and WALTER RISON, or the survivor of them, all remaining tangible personal property;
 - C. To SUSAN PATTON the land and improvements thereon known as 13400 Rock Point Road, Newburg, MD 20664 (or the proceeds of sale if she prefers), provided that she survives WILLIAM EDWARD RISON by 30 days or more;
 - D. To CHARLES RILEY shall have the option (to be exercised within 90 days of the death of WILLIAM EDWARD RISON) to purchase at market value the land and improvements thereon known as 11105 Milton Hill Place, Newburg, MD 20664;
 - E. To SUSAN PATTON any and all bank accounts, provided that she survives WILLIAM EDWARD RISON by 30 days or more; and
 - F. All of the rest, residue, and remainder of the trust estate (real, personal, and mixed) forever as follows:
 1. Fifty percent (50%) thereof to SUSAN PATTON, provided that she survives WILLIAM EDWARD RISON by 30 days or more; and
 2. All of the balance to those of the following charities legally extant and qualifying as tax-exempt at the time of the death of WILLIAM EDWARD RISON:
 - i. Healthwell Foundation, 20440 Century

Blvd., Suite 250, Germantown, MD
20874 (Tax ID number 20-0413676) for
their general purposes; and

- ii. The Salvation Army Southern Territory,
1424 Northeast Expressway, Atlanta,
GA 30329; Telephone: 866-551-7585
(Tax ID number 58-0660607).

II. If SHERRY LYNETTE RISON was the surviving Grantor,
then upon her death distribution of the trust estate shall
be as follows:

- A. \$10,000.00 to PAM PHILLIPS (6903 Brown Ridge
Drive, Shawnee, Kansas 66218) provided that she
survives SHERRY LYNETTE RISON by 30 days or
more;
- B. \$1,000.00 to SHIRLEY PATTON (32845 NE 2100th
Road, Greeley, Kansas 66033) provided that she
survives SHERRY LYNETTE RISON by 30 days or
more;
- C. \$1,000.00 to HALLIE M. KUGLER (537 Collicello
Street, Harrisburg, Virginia 22802) provided that she
survives SHERRY LYNETTE RISON by 30 days or
more;
- D. To WALTER RISON all of the astronomy,
photography, and computer equipment, including the
right to move the observatory if he so chooses,
provided that he survives SHERRY LYNETTE RISON
by 30 days or more;
- E. To SUSAN PATTON and WALTER RISON, or the
survivor of them, all remaining tangible personal
property;
- F. To SUSAN PATTON the land and improvements
thereon known as 13400 Rock Point Road, Newburg,
MD 20664 (or the proceeds of sale if she prefers),
provided that she survives SHERRY LYNETTE
RISON by 30 days or more;
- G. To CHARLES RILEY I leave the option (to be
exercised within 90 days of the death of SHERRY
LYNETTE RISON) to purchase at market value the
land and improvements thereon known as 11105
Milton Hill Place, Newburg, MD 20664;
- H. To SUSAN PATTON all remaining money in any and
all bank accounts, provided that she survives
SHERRY LYNETTE RISON by 30 days or more; and

- I. All of the rest, residue, and remainder of my the trust estate (real, personal, and mixed) forever as follows:
 1. Fifty percent (50%) thereof to SUSAN PATTON, provided that she survives SHERRY LYNETTE RISON by 30 days or more; and
 2. All of the balance to those of the following charities legally extant and qualifying as tax-exempt at the time of my death:
 1. Healthwell Foundation, 20440 Century Blvd., Suite 250, Germantown, MD 20874 (Tax ID number 20-0413676) for their general purposes; and
 2. The Salvation Army Southern Territory, 1424 Northeast Expressway, Atlanta, GA 30329; Telephone: 866-551-7585 (Tax ID number 58-0660607).

4. Section 7 is rescinded in its entirety and left blank.

5. Subsection A of Section 8 is amended as follows:

- I. VERNON ALBERT PATTON is removed as Second Successor Trustee and replaced with EDWARD W. OLMSTED and WILLIAM F. OLMSTED as Second Successor Trustees;
- II. DENISE A. MARTIN is removed as Third Successor Trustee; and
- III. All remaining terms of Subsection A of Section 8 shall remain in force.
